ELDER ABUSE

Abuse can happen to anyone — no matter the person's age, sex, race, religion, or ethnic or cultural background. Each year, hundreds of thousands of adults over the age of 60 are abused, neglected, or financially exploited. **This is called elder abuse.**

Abuse happens, it may happen in the older person's home, a family member's house, an assisted living facility, or a nursing home. The mistreatment of older adults can be by family members, strangers, health care providers, caregivers, or friends.

Types of elder abuse, neglect and exploitation may include:

Physical Abuse

Emotional or Psychological Abuse

Abandonment

Financial or Material Exploitation

Self-neglect

Sexual Abuse

What to do if you suspect abuse, neglect, or exploitation of a vulnerable adult:

1. If this is a case of **immediate danger**, call **911** and report a crime to law enforcement. Call **Adult Protective Services (APS)** in Pierce County anytime day or night to report the concern at **(877) 734 6277** or **1-866-ENDHARM (363-4276)**.
2. When you call, you will speak with a real person who will connect you to the direct, local number to make your report.
3. If the abuse is happening at a long-term care facility, call the **Pierce County Long Term Care Ombudsman** at **253-798-3789**.
4. Call the **Pierce County Aging and Disability Resource Center (ADRC)** to discuss your concerns and receive additional resource information at **(253) 798-4600** or (800) 562-0332.
5. The **Pierce County law enforcement** non-emergency number: **(253) 287-4455**.

OBSESSIVE COMPULSIVE DISORDER

Hoarding is more than just having lots of things. It is a specific type of behavior that can have a severe impact on a person's life. Compulsive hoarding is a specific type of behavior marked by acquiring and failing to throw out items that would appear to have little or no value to others, severe cluttering of the person's home so that it is no longer able to function as a viable living space, and significant distress or impairment of work or social life.

MEDICAL ALERT SYSTEMS

A medical alert system provides you with a button you can push for assistance during an emergency. The help button is usually worn as a [pendant](#) or wristband, but you can also place buttons on the walls throughout your home. These buttons can be [monitored](#) or [unmonitored](#).

3 key questions to answer before choosing your medical alert system.

1. Do you want home-based (landline) or mobile (cellphone)?
2. Should your system be monitored or not?
3. Should you add fall detection?

If you live anywhere in Pierce County, apply for this free service by contacting the Aging & Disability Resource Center at (253) 798-4600 or (800) 562-0332.

The Reassurance Program promotes security of “at risk” seniors, reduction of isolation, victimization, and health concerns, and provides daily telephone reassurance calls.

Participants receive a phone call (up to five days a week at a prearranged time) from a trained volunteer working with law enforcement agencies in Pierce County. If the participant does not answer the phone, a procedure of safety checks is followed before an emergency response (911) is initiated.

HOME CARE – HOME HEALTH

HOME CARE, Home care is care that allows a person with special needs to stay in their home. It might be for people who are getting older (aging in place). It could also be for people who are chronically ill, recovering from surgery, or have a disability.

HOME HEALTH, Home health is medical care provided in a patient's home. Home care can include broad care given by skilled medical professionals, including skilled nursing care, physical therapy, occupational therapy, and speech therapy. Home health care can also include skilled, non-medical care, such as medical social services or assistance with daily living from a highly qualified home health aide. As the Medicare program describes, home health care is unique as a care setting not only because the care is provided in the home, but the care itself is "usually less expensive, more convenient, and just as effective" as care given in a hospital or skilled nursing facility.

HOSPICE CARE

Hospice care is a special kind of care that focuses on the quality of life for people and their caregivers who are experiencing an advanced, life-limiting illness. Hospice care provides compassionate care for people in the last phases of incurable disease so that they may live as fully and comfortably as possible.

The hospice philosophy accepts death as the final stage of life: it affirms life but does not try to hasten or postpone death. Hospice care treats the person and symptoms of the disease, rather than treating the disease itself. A team of professionals work together to manage symptoms so that a

person's last days may be spent with dignity and quality, surrounded by their loved ones. Hospice care is also family-centered – it includes the patient and the family in making decisions.

PALLIATIVE CARE

Palliative care is specialized medical care for people living with serious illnesses, such as cancer or heart failure. Patients in palliative care may receive medical care for their symptoms, or palliative care, along with treatment intended to cure their serious illness. Palliative care is meant to enhance a person's current care by focusing on quality of life for them and their family.

The Mustard Seed Project provides two major types of senior transportation:

1.VOLUNTEER DRIVERS: Screened volunteers provide free door-to-door transportation in their own vehicles, to qualify, riders must live on the Key Peninsula, be aged 60 or older or a medically disabled adult over the age of 18 with a combined household income of \$3,000 or less after subtracting rent/mortgage and out-of-pocket medical expenses. All rides must be scheduled with 7 business days advanced notice (business days are Monday through Friday). Eligible adults can request round-trip rides for medical appointments, grocery shopping, social outings and more. This program is made possible through our partnership with Catholic Community Services. Though this service is free, donations are always welcome.

2.COMMUNITY SOLUTIONS MINIBUS: No income eligibility requirements. The Mustard Seed Project partners with Pierce Transit to provide this service to seniors and disabled adults on the Key Peninsula who require the use of a wheelchair lift to access medical appointments. Volunteer drivers are pre-screened, trained by Pierce Transit to operate the wheelchair lift equipped shuttle-style mini-bus, and must pass a defensive driving course. If you have Medicaid, please check with your insurance to see if you qualify for paratransit for medical rides. We may offer more transportation options in the future, call 253-884-2216 for information. Every rider is required to complete an ADA -application, to determine eligibility for partial or full transportation considerations. For rides and information, call 253- 884-2216.
